Nobody Pays Retail: Calculating the Reasonable Value of Past and Future Medical Care in Traumatic Injury Lawsuits

There is a long tradition in the U.S. medical care industry of providers submitting bills and charges for services rendered, but accepting much less than those amounts in full satisfaction of those charges. Given that these charged and billed amounts are not rooted in any economic or business theory of value (*e.g.*, "fair market value"), there is a very high rate of variation in charges. Likewise, there are various methodologies in the field of health economics to calculate reasonable fair market value of medical services in personal injury liability cases. Valuation methods include considerations of geographically adjusted fair market value of past and projected services (including drugs and supplies), adjustments to life expectancy, and considerations of post-injury coverage via the Affordable Care Act, Medicare, or Medicaid. Join us for a review of these issues, with particular focus on traumatic brain injury cases resulting from construction accidents.



Defense Tactics to Refute Emerging Attempts to Impose a Higher Standard of Care on Commercial Truck Drivers

Can a commercial truck driver commit professional malpractice? The answer surely should be a resounding "no." Some recent decisions, however, have affirmed plaintiffs' attorneys' attempts to impose a higher standard of care on commercial truck drivers through the use of guestionable experts and arguably improper jury instructions on the issue of negligence. Characterizing truckers as "professional drivers," plaintiffs' attorneys argue that the "superior knowledge" of these professional drivers establishes a standard of care of what a reasonable semi-truck driver would do under the circumstances as opposed to the duty of any driver to exercise ordinary care. Courts have agreed. To avoid this emerging trend, in part the result of reptilian tactics, this presentation provides an overview of the pertinent decisions from throughout the country, and outlines a number of defense tactics to be invoked by defense counsel, including methods for challenging plaintiffs' experts, arguments for motions in limine, and grounds for attacking overly broad and improper jury instructions.

Bad Blood? FDA Regulation of Laboratory Developed Tests and Potential Litigation Implications

In the wake of issues faced by companies like Theranos and 23andMe, laboratory developed tests have been a hot topic in the news the past several years. A laboratory developed test (LDT) is a type of in vitro diagnostic test that is designed, manufactured, and used within a single laboratory that is not approved or cleared by the FDA. Since 1988, the laboratories performing LDTs have been highly regulated by a comprehensive federal statutory framework under the Clinical Laboratory Improvement Amendments, but for the last few years, the FDA has expressed its intent to regulate LDTs as medical devices. This dynamic panel will explore the current regulatory framework in place, the possible implications from the change in administration, and the potential for litigation.




THE CHICAGO FLAG



tion and warbirds, and applied to the Air National Guard to fly F-16s as soon as she learned that Congress had opened combat aviation to women. The first and only woman in the 121st Fighter Squadron. She flew the F-16 for ten years before having to make the difficult decision to leave the fighter aviation as a single mother. She works now for Lockheed Martin as the Director of Air Force Aviation Training Systems, specializing in capture management, government relations, and strategic business development.
