Auto Pay Terms and Conditions

The following terms and conditions apply if you are enrolled in AutoPay:

By opting in for the automatic membership dues renewal on the reverse side, you hereby authorize DRI, Inc. on a recurring and automatic basis to annually renew your DRI membership and NFJE contribution (NFJE is an optional \$35 fee) and charge the applicable membership and the optional NFJE donation to the credit card that you place on file.

You understand that DRI will initiate charges pursuant to this authorization not to exceed the amount shown on your DRI invoices. DRI will initiate transfers or charges each year on the date your invoice is due.
